Apart from that the owners would have the satisfaction of seeing,


the land put to good use.

No eviction over unpaid heat bill

LIVERPOOL Corporation have dropped their threat to evict a Toxteth mother who refused to pay for electricity she hadn't used.

Wendy Leader was due to appear in court for 'rent arrears' because the corporation consider the £2.15a-week heating charge is part of the rent.

All the flats in Entwistle Heights have electric under-floor heating in two rooms. The system is automatic and tenants have no control over it.

Wendy's problem is that she lives on Social Security and the SS refuse to include the heating charge when they pay her rent. They allow her 47p a week and say she must find the rest from her living allow-

She had no alternative but to turn off the heating at the meter.

By stopping their court action the corporation have avoided an embarrassing problem. It's not at all certain they would have won the case, and if they'd lost it would have set a precedent allowing other tenants to refuse to pay without fear of eviction.

Still, this hasn't stopped several others in the block from following Wendy's example and turning the heating off.

Tenants complain that the system heats living rooms and kitchens - but not bedrooms - at night, and makes food go off quickly.

There are also complaints that it doesn't work properly, though the corporation point out that it is only 'background' heating and electric fires are necessary as well.

Wendy and some friends did a survey which showed the tenants in the block wanted to control their own heating. The corporation did a survey which showed the opposite, and suggested the tenants had not worded their questions properly.

So now a third survey is to be done when both sides agree on the wording of the questions.

The corporation also plan to test the heating system with clocks and thermometers, but there have

been long delays. First they said there were no empty flats to put the equipment in.

Then "when a flat became vacant... it was found to be infested and before the test could be started disinfestation had to be arranged."

A third attempt proved "inconclusive" because of the hot weather.

Possibly they will eventually come to the same conclusion that was reached six years ago by housing chairman Gordon Pascoe when he said underfloor heating had "failed miserably".

"The system was not necessarily inefficient but the specification was utterly inadequate and the workmanship in many cases was thoroughly bad."

Repair sense

COUNCIL workmen are refusing to move a fence in Cantril Farm because they say there is more urgent work to be done.

The fence surrounds a tenant's garden in Barons Hey and officials had planned to enlarge the garden by moving the fence 10ft on one side and 20ft on the other.

They estimated the work would take 183 hours and cost several hundred pounds.

Gerry O'Neill, senior steward at Dovecot Maintenance Depot protested when he heard about it.

"The department is supposed to have no money," he told the Free Press. "All the tenants are going to complain and we're the guys that's going to have to take the brunt."

He said the rule on these repairs at the moment is 'emergencies only' -fences which are dangerous, or which are needed to stop children running into a road.

He knew of fences in the same area which were in a bad state, and one tenant who had been waiting two years for repairs.

offered to pay for extra wiring to convert some blocks of flats from tenant-controlled to corporationcontrolled heating.

They argued that the corporation would save money because even temperatures throughout blocks of flats meant less main-

It would also shift the work of collecting the money and chasing bad debts from Manweb to the corporation.

 Entwistle Heights was designed by the late Dr Donald Bradbury, City Architect. Several of his projects have been struck by misfortune. Oak and Eldon Gardens in Birkenhead are having to be demolished after only 18 years. And his parting gift to Liverpool - a crematorium - was found to be in danger of exploding when used.

Action group for tenants

LIVERPOOL Tenants' Action Group was formed from a group of people who successfully fought the council's plan to alter tenancy agreements. The plan would have made tenants responsible for maintaining communal areas of flats, maisonettes and tenements.

Individuals and representatives of community groups have been meeting regularly, aiming to mobilise on issues needing immediate action such as charges for minor repairs, and rent rises. They also hope to draw up a tenants' charter.

IT IS NOW three years since I first made my complaints to the Corporation Housing Department about the state of this new house.

As you know my wife suffered terrible injuries when the cooker dropped back into holes and caused a pan of hot fat to fall on her feet. and with the evidence still here for all to see, I still can't get compensation for her.

The faceless monsters pass the buck to Cubitts who have just been to the estate and taken samples of the floors of a number of houses.

I also had no central heating or hot water for almost a year and I still have not had a refund of part rent and rates, so I helped myself to three weeks' rent. Now the faceless. monster known as J. Hall is going to have me evicted from the house.

How does one get justice when dealing with this mafia-like set-up? I rang the Area Office at Clubmoor on Friday the 13th and they now say they don't know a thing about my complaints. Yet Mr Molyneux (Estates Dept at Blackburn Buildings) told me on Tuesday August 10 that he had refused to accept the house and Cubitts had not been paid because of the complaints made by me.

I have got Councillor Ken Stewart trying to do something about it but it all seems impossible. A bunch of bandits in public office - they can't be sacked, questioned or brought before the court because I don't have the money and Legal Aid is just a
